





The Chairman Dr. B.R. Prasad Neerukonda extended warm welcome to the Governing Body Members, and also introduced Prof. Sandeep Grover, Nominee of UGC whose visit is first time to this Institute.

- 1. The Governing Body examined the resolutions taken in the 36th BoG Meeting held on 28-06-2015 and resolved to endorse the minutes of the meeting
- 2. The action taken report on the minutes of the previous meeting was presented by the Principal and was accepted.
- 3. The appointments that were made subsequent to the previous Governing Body meeting were placed before the members for ratification. It was unanimously resolved to ratify all the appointments that were made from the date of the earlier meeting till date, and further the members of BoG accepted to promote Dr. N. Padmaja, Associate Professor, Chemistry and Dr. V. Rupa, Associate Professor, English to the cadre of 'Professor' under Career Advancement Scheme (CAS) taking in to consideration of their Qualification, Experience and performance.
- 4. The BoG Members ratified the proposal of the Principal to conduct meetings of Board of Studies of all academic Departments on 26-03-2016 and that of the Academic Council on 02-04-2016.
- 5. The results of B.E./B.Tech. IV/IV & I/IV I Semester (2015-16) were analyzed after being reported by the Principal and the members have expressed satisfaction over the results of all the Departments, especially, the first year which is the 1st batch under Autonomous system.
- 6. The placements report was presented by the Principal who explained that more than 398 candidates got placements so far in 2015-16 in several organizations like Deloitte Consulting, Voonik Technologies, MuSigma, Model N India Software, Verizon Data India Services, Kony Labs, Teradata India, Infosys Technologies Ltd, Capgemini India IBM India Software, Ux Reactor, Polaris Financial Technology, Genpact, Apxor Technology, MphasiS, Cognizant, Yantranet, Oean India, Mind Tree, Formic Inc, Persistent Systems, Sonata Software Ltd and Amazon India etc. This is the highest percentage of placements achieved so far among all the private engineering colleges in this region. Further the Principal appreciated the efforts put in by the Placement Cell in this direction
- 7. It was resolved that additional space can be provided by constructing I-Block in the place of existing sheds near to the Canteen to meet the future requirements.
- 8. The members examined the report that was submitted to AFRC on fixation of Tuition Fee by AFRC for UG and PG programs for the block period 2016-17 to 2018-19, and expressed that it will be extremely difficult for the institute to adhere to the prescribed scales unless the proposed fee for UG at Rs. 1,03,888/-and PG at Rs. 85,000/-based on 2014-15 audited accounts and projections for the block period, is awarded.
