This has reference to Appeal dated 06-02-2020 filed by **Anil Neerukonda Institute of Technology and Science, Sangivalasa, Bheemunipatnam Mandal-531162, Visakhapatnam, Andhra Pradesh** against the decision of NBA for not granting accreditation to UG Engineering programs of your Institution, communicated vide NBA's letter of even number dated 20.12.2019.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 23-08-2021. The Appellate Committee recommended for holding re-visit to **Anil Neerukonda Institute of Technology and Science, Sangivalasa, Bheemunipatnam Mandal-531162, Visakhapatnam, Andhra Pradesh** for re-evaluation of following UG Engineering programs. An online re-visit was held from 17<sup>th</sup> to 19<sup>th</sup> December, 2021. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:
